



Volunteer Hold Harmless Agreement 2026

Thank you for volunteering with Cosumnes Community Services District (Cosumnes CSD). Your support helps us serve our community and provide excellent customer service! Before volunteering, please sign the Hold Harmless and Media Release Agreement for the current year and return it to Cosumnes CSD staff. Volunteers under 18 must have a parent or guardian's signature.

Hold Harmless Agreement. The Cosumnes Community Services District, their officers, employees, agents, and volunteers, and any co-sponsor of its activities, to the fullest extent allowable by law, are not responsible for any injury or damage which may be suffered by the volunteer while traveling to, during, or returning from volunteer service ("Activity"). The Cosumnes CSD has no medical insurance for individuals, and any injury to, or caused by, the volunteer will be the volunteer's sole and exclusive responsibility including, but not limited to, personal injury, disability, death, illness, damage, loss, liability, or expense. Volunteer, or their parent or guardian if actual volunteer is under 18, hereby agrees to indemnify, defend, and hold harmless the Cosumnes CSD and their officers, employees, agents, and volunteers, and any co-sponsors, from any and all claims for bodily injury (including death), and other liability, damages, lawsuits, expenses (including but not limited to, medical expenses and attorney's fees) caused by the volunteer's negligence or willful misconduct, in the performance of the Activity. Volunteer understands and agrees that this release includes any Claims based on the actions, omissions, or negligence of Cosumnes CSD, its officers, employees, agents, and volunteers.

Volunteer, or his/her parent or guardian if actual volunteer is under 18, shall be solely and exclusively responsible for any and all property damage, personal or private, which the individual may cause during the course of an activity or event where he or she is serving as a volunteer. This provision shall survive the expiration of the Agreement.

Media Release Agreement. The volunteer, or parent or guardian if actual volunteer is under 18, unconditionally authorizes and consents to the Cosumnes CSD using videotape, photographic, electronic and/or any other media image, quotations, likeness, or electronic or photographic reproduction in any manner, in whole or in part, for any and all educational, promotional, marketing, news, or outreach activities of the Cosumnes CSD.

Attestation. By signing below, I acknowledge that I have read and understand this notice and, if I am signing on behalf of a volunteer under the age of 18, I attest that I am that volunteer's legal guardian and am signing on behalf of the minor. I further understand that this agreement is valid for the above named individual when volunteering with the Cosumnes CSD in the 2026 calendar year.
