



FREQUENTLY ASKED QUESTIONS

How do I pay for my party?

Payment for your party is due in full at the time of reservation. Reservations can be done in person, online, or over the phone. All reservations are first-come, first-served and based on availability. Payment methods accepted: Card (Visa, Discover, MasterCard), cash (nothing higher than \$20), check (written out to Cosumnes CSD), or Apple Pay.

What if the date I want is already full?

Unfortunately, there is no waiting list for Pool Parties. All reservations are first-come, first-served and based on availability.

How early can I enter the party area to set up?

The host(s) may enter the party area **15 minutes** prior to party time to set up, with one additional person to help.

What if I have more than 30 guests?

We limit the guest list to 30 guests maximum for the Splash and Wave Parties. This includes the host(s), guest of honor, all parents/guardians, all children, all swimmers and non-swimmers. If you have over 30 guests, you must purchase a second party, held at the same time. Parties with attendance higher than 60 guests (2 parties at the same time) may want to consider a Private Splash Island or Private Treasure Island Party, held before Recreation Swim hours, allowing 50 guests or an Aquatics Facility Rental, held after Recreation Swim hours (www.CosumnesCSD.gov/PoolRentals).

Who is considered a "guest?"

Anyone who is attending the party is considered a guest. This includes the host(s), the guest of honor, all parents/guardians, all children, all swimmers, and non-swimmers. Only children under 2 years old will not be counted against your guest list total.

What if we want to stay longer in the Aquatic Facility before or after the designated party time?

For the Splash and Wave Parties, guests are only allowed into the facility, and to stay in the facility, during the duration of that facility's Recreation Swim hours. Guests are only allowed in the party area during their designated party time, but may enjoy the rest of the facility during non-party times.

For the Private Splash Island and Private Treasure Island Parties, guests cannot enter any earlier than their designated party time, however all guests will be able to stay and enjoy Recreation Swim after the conclusion of the party. All guests must clean up and vacate the canopy area/room by the end of their reservation. Please keep in mind that, while there is private use of Splash Island/Treasure Island during your rental, the remainder of the facility will be open for other programs.

By what date do I need to submit my guest list?

The submission deadline for the guest list is the Thursday before your event. Should it not be submitted by this time, a printed guest list must be handed to Cosumnes CSD Pool Party staff at check-in. Access will not be granted to any guests without a provided guest list.

What can I bring in for my party?

You can bring in decorations, balloons, lawn chairs, or additional food such as cake or cupcakes to make your party more personal. The facilities do not allow confetti, barbecue grills, open flame food warmers, glass, sharp objects, or alcohol. Please be advised, the facilities do not provide any storage, electricity, or refrigeration. Smoking/vaping is also prohibited.

Is there any storage or refrigeration provided?

No, the facilities do not provide any storage, electricity, or refrigeration for pool parties. We are not responsible for your food or other belongings and do not have the ability to store them for you. All food items must remain with you at your pool party area. We suggest avoiding ice cream/ice cream cakes or anything that cannot survive in your ice chest. Everything, including decorations, must be removed by the end of your rental.

What if I need to cancel or change my party?

Cancellations, refunds, and date transfers are only granted 72 hours prior to the party. Please contact the registration office at 916-405-5600 for your request.
