



## Cosumnes Recreation Opportunity Fund GUIDELINES - 2026

The Cosumnes Recreation Opportunity Fund subsidy is a financial assistance program for low-income households in Elk Grove interested in participating in recreation opportunities offered by the Cosumnes CSD.

### Program Qualifications:

1. Applicants must reside in the 95624, 95757 or 95758 zip code areas. Current **proof of residency** is required; submit either a CA driver's license or utility bill; P.O. boxes not accepted. Accepted utility bills are electricity, gas, water, sewage, and trash services. Statements provided must be in the applicant's name, have a recent date and show the qualifying Elk Grove address.
2. Applicants' household income must be within the allowed household income range\* as indicated in the table.
3. **Proof of income** in the form of the previous year's income tax return is required for *each* member of the household who is 18 years or older at the time the application is submitted. The only exceptions are recipients of Welfare, Social Security, Disability, Food Stamps, and Unemployment benefits. Individuals receiving these services can provide a copy of a current acceptance letter into the program as proof of income. W-2 forms and paycheck stubs are not accepted.
4. All qualifying documents must be in the applicant's name.

### Funding Information:

- The Cosumnes Recreation Opportunity Fund subsidy resources are limited and subject to availability. Complete applications will be processed on a first-come, first-served basis.
- Applications will be accepted throughout the calendar year, until 50 applications have been approved.
- Funding is limited to \$300 per qualified household, per calendar year, and will *only* be applied to those family members listed on the application at the time of original submittal.
- The Cosumnes Recreation Opportunity Fund subsidy is in the form of a scholarship fund linked to the recipient's Cosumnes CSD account; there is no cash value and funds are valid until December 31<sup>st</sup>.
- Recipients of the Cosumnes Recreation Opportunity Fund subsidy do not receive priority registration. Funding can *only* be used within the approved calendar year for programs that fall within that same year.
- All unused funds will be deleted from accounts at the conclusion of the calendar year.
- The Cosumnes Recreation Opportunity Fund subsidy may *only* be used for certain programs/activities, leagues, and memberships. It may not be used for CORE Memberships, Drop-in Activities (Open Gym, Recreation Swim, Swim for Fitness) paid day-of on-site, Facility Rentals (aquatic facilities/pool parties, gyms/courts/fields, picnic sites, rooms/halls), and Swim for Fitness Auto-Pay Membership.
- If the cost of a class or program exceeds the Cosumnes Recreation Opportunity Fund subsidy, then it is the responsibility of the recipient to pay the remaining balance due at the time of registration.
- The Cosumnes Recreation Opportunity Fund subsidy may not be used for optional supply fees; those supply fees must be paid directly to the instructor upon request.
- The Cosumnes CSD Refund Policy applies to all program registrations. If a refund request is approved, the funds will revert to the scholarship fund.
- Application must be approved before the Cosumnes Recreation Opportunity Fund subsidy can be used for any registrations and will not be applied toward programs already registered for.

All denied applications will receive an email and all approved applications will receive an email and a phone call regarding their funding status. - Registrations may only occur for those listed on the original application from within the calendar year the applicant was approved for. If space is available in the desired program, the applicant can be registered.
- All incomplete, invalid, or falsified application packets will be denied funding.
