Cooking Vendor

- ☐ One 2A-10 BC Extinguisher, One K extinguisher for Grease cooking
 - Must be serviced and tagged within the last year.
- ☐ Fuel and/or propane tanks must be secured and 10 feet away from appliances.
- ☐ No cooking or open flames under canopies/tents.
- ☐ All four legs of canopies/tents must be secured/weighted.
- ☐ Generators must be 10 feet away from any propane/fuel or appliance/truck/canopy/tent and secured with fencing.

General Vendor

- ☐ Fuel and/or propane tanks must be secured and 10 feet away from appliances.
- ☐ No cooking or open flames under canopies/tents.

Food Trucks

- ☐ One 2A-10 BC Extinguisher, One K extinguisher for Grease cooking
 - Must be serviced and tagged within the last year.
- ☐ No broken or missing appliances/stoves
- ☐ Hood serviced within the past 6 months – must have tag.
- ☐ Wheels shall be chalked.
- ☐ Generators must be **10 feet away** from any propane/fuel or appliance/truck/canopy/tent and secured with fencing.
- ☐ Food trucks shall be parked at least 20 feet from canopies/tents and/or buildings.
