### APPLICATION CONDITIONS

1. Cosumnes CSD accepts applications starting February 2, 2026, for the summer season. Applications are received on a first-come, first-served basis and will be processed in order of acceptance. You will be notified by email when the application is approved and your permit is ready.
2. **The renter must obtain insurance through an outside vendor or provide liability protection through their Homeowners or Tenants insurance. The renter may not decline liability insurance.**
3. Reservations are only held for 2 weeks, during which time permit signature, liability protection insurance, and full payment all must be completed.
4. Applications must be received at least 30 days before the event date.
5. A two-hour minimum is required for all Aquatic Facility Rentals. Set-up time is included in that time.
6. There will be no early entry for set-up.
7. Renters will have 15 minutes after the reservation to clean up and exit the facility.
8. Amplified sound can only be used by authorized district personnel to play our licensed music.
9. Cosumnes CSD provides American Red Cross certified and trained lifeguards.
10. No refunds will be issued for cancellation requests that occur within 60 days of the event date.
